Multi-Configuration SAML Framework required

- Older orgs used to only support one single-configuration SAML framework
- Only a problem if you see this in Release Updates in setup
- Migrate before your SSO breaks
- Enforced in Summer 24 release

MFA will merely annoy you into compliance instead of forcing it

- MFA is required for all UI logins
- Instead of outright blocking you from logging in, in Summer 24, you'll get an in app guidance notification instead

API Only Minimum Permission Profile

- Remember the "Salesforce API Only System Integrations" standard profile that was rolled out a few releases ago?
- That profile had a few more permissions than it really needed. Oops.
- "Minimum Access API Only Integrations" should be used instead. Don't use the other one.

No Downtime for core releases

- Starting with Summer 24, no more "5 minute outage" for major releases
- But users will need to login again
- Only applies to Hyperforce instances


New Setup Domain

- Setup pages are now being hosted on *.salesforce-setup.com
- Check your firewall rules if your traffic is heavily locked down

Salesforce native Backup & Restore

- Now supports backing up files and attachments
- Can initiate delta backups on demand










Event Log File Browser (Beta, Demo)

- Download event monitoring logs right from setup
- Requires Shield or Event Monitoring Add On









Add fields from related (lookup) objects with dynamic forms (Demo)

- No need to create formula fields to see data from the parent record
- See Account field values on an Opportunity page
- These fields are not available on list views or reports, just the lightning page

API Name now shows on dynamic forms (Demo)

- You see the label and the API name
- Great if you do horrible things like multiple fields with the same label
- · Also helpful to know which fields go to a parent object, because parent/child sometimes share labels







Required Field widget (Demo)

- Just a little notice on the create screen
- Doesn't know about validation rules, just required fields at the field/page level

Multi-select Picklists (Demo)

- Do you like multi-select picklists?
- Go ahead and create one

See which Flows are using an Email Alert (Demo)

- Email alerts have moved from workflows/process builder into Flows
- See what is used where







Rearrange Multiple Report Columns at Once (Demo)

- Select or Command/Control click columns and drag them
- Drag to a column or drag up/down the list
- They all move as a big block, even if they weren't next to each other


Seller Home

- New default home page for Sales app
- Appears automatically unless you set a custom home page
- Not available in developer edition













Repeater Element (Beta, Demo)


- Create an input where the user can specify multiple entries
- Access all of the entries as a collection variable and use loops

Run As Workflow User

- Flows can listen and respond to platform events
- Choose to run the flow as the user who triggered the flow or as the default workflow user

Trigger Flows from Activity Insights

- Fire off a flow based on Einstein Activity Capture or Einstein Conversation Insights events
- Access the data in these as well
- Included with UI. Add-on for Pro/EE editions

ANT is EOL

- The Ant migration tool is now retired
- Continues to function but no more updates and isn't supported
- Switch to SF CLI

Null Coalescing Operator

- Use ?? To return the left hand argument if the left hand is not null, otherwise return right
- A ?? B returns A if it is NOT null. If A is null, returns B.

ApexGuru Insights is GA

- Code and SOQL analysis, showing problem areas, high CPU usage and unused code using AI
- Enable in Scale Center
- Available for UE and Signature Success







Workspace API

- Now available for LWCs
- Open and close tabs, subtabs, set focus, refresh

Mobile Document Scan

- DocumentScannerAPI to scan documents with LWCs
- Uses the device's camera and OCR
- Only available for mobile devices, not desktop

Create and Extract Zip Files in Apex (Developer Preview)

- Compress and decompress files inside Apex
- Create multi-file archives
